Surf Official Re-licensing Information

SLSA's endorsed points system for maintaining status as a SLSA Surf Sports Official is defined by the terms of reference, on the following page. 100 points must be achieved prior to the 31st December in the year the license expires to maintain status as a licensed Surf Sports Official. These must be completed within the period of the license which is Four Years for all levels.

Whilst the points system recorded on the following page is the major determining factors in the re-licensing process, the National or State Officiating Advisor / Coordinator retains the right to request additional information before granting a license as the official must sustain the licensed officiating standard required for their current level

The schedule on the prior page describes the credit points you receive for participating in updating activities. Each individual activity will gain points, eg; Officiating at 5 club carnivals in a year will earn (5x5 points) a total of 25 points for that year. The National Officiating Advisor will expect Level 3 Officials to achieve a higher level of participation in addition to accumulating the necessary credit points during the license period. Any other activities you wish to apply for credit should be negotiated with your State Competition Officials Education Advisor / Co-Ordinator.
